PREAMBLE

Whereas, Raja Birendra Chandra College and Gushkara Mahavidyalaya have many areas of common interest in Arts, considerable advantage may be gained from their pursuit of academic excellence on a scollaborative basis in the fields of academics, pedagogy and research.

ARTICLE 1: OBJECTIVES

- vi) Undertaking joint research wherever feasible

- viii) Conducting study tours and joint consultancy work wherever feasible
- ix) Each Teacher will be responsible for his / her own transportation and daily allowances to and from the host institution.
- To use library reading room facilities for a specified period.
- To use laboratory facilities in specific cases (with prior approval of Principal) for a limited period.

A specific plan will be worked out for each activity and detailed arrangements for such collaborative work will be agreed upon.

Raja Birendra Chandra College and Gushkara Mahavidyalaya agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two colleges. These terms will include a technical description of the proposed activity, financial arrangements and person(s) gresponsible for its implementation.

ARTICLE 2: COORDINATION

Each college shall appoint one member of its teaching faculty to coordinate the programme on behalf of the Principal of each college. Further, a Coordination Committee consisting of two Principals and the two coordinators will periodically (once or twice a year) review and identify ways to strengthen cooperation between two colleges.

ARTICLE 3: CONFIDENTIAL INFORMATION

The two colleges will retain and respect individual confidentiality, including those pertaining to the collaborative activities of both colleges.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested in both the colleges in this MoU. Both the colleges shall have right to determine the commercial implications, disposition and exploitation of such intellectual property and shall make joint applications for the registration of the same. Any publication regarding such intellectual property shall be possible with prior written consent of both colleges.

ARTICLE 5: VALIDITY

The MoU shall remain in force for a period of five academic year commencing from the effective date (18th May 2023 to 17th May 2028. Institutions may extend the term by written agreement signed by both after review.

ARTICLE 6: TERMINATION

Either institution may terminate the MoU by giving written notice of one month in advance to the other institution.

A. Opening of GeM Pool Account

The NPAE hereby agrees to open GeM Pool Account (GPA) with the Bank. GPA opened will have following core elements:

- The NPAE will open the GPA (as a non-operative saving or current account) which will be utilized by buyer through the platform owned and maintained by GeM, as per SLA and solely for procurement of goods and services on GeM.
- No cheque book will be issued for GPA
- The terms and conditions of procurement on GeM will be part of the operations manual between bank and the NPAE.
- Maximum 3 GPA would be allowed for one NPAE or as may be decided by GeM from time to time.
- Details of all operations of the account will be shared by the bank in mutually accepted format with the NPAE.
- The NPAEs are not permitted to use GPA for any payment/operation outside GeM
- Once a sub-account / transaction specific account is credited with an amount, the NPAE cannot withdraw this amount, apart from transfer to the designated supplier till such time that the transaction is live.
- Any withdrawal / transfer by the NPAE from this account, except for payment to the supplier, would be permitted in the following conditions
 - Order cancellation
 - Order rejection
 - Refund

B. Registration of GPA

The NPAE will provide the duly filled application form, signed by authorized signatory of GPA account to the Bank with required details for registration of account in Bank's system linked with GeM portal..

C. Operations of GeM Pool Account

The transactions on GeM are ongoing process on the GeM platform. It is clarified that in lines with GeM T&C on procurement, the GPA would be utilized for all E-Procurement of goods and services of value above INR 10 Lakhs, mandatory through the pool account and optional at the discretion of the entity for all procurement of value upto INR 10 Lakhs, by all the buyers registered as NPAE on GeM portal. The GPA would provide for creation of unlimited DDO/ Department accounts and transaction specific virtual accounts within the GPA to uniquely identify and manage the funds Department-wise for each order/ transaction on GeM. Each procurement by the NPAE is referred to as a uniquely identified transaction on GeM portal.

Bank will open virtual accounts for all DDO / Departments registered on GeM under the NPAE based on the instructions received from GeM. The Buyer under the NPAE will fund the GPA in advance as per agreed terms of GeM and utilize the funds as per core elements of GeM Pool Account.

Funding in GeM Pool Account

Following options are provided by GeM to NPAE for funding the GeM Pool Account which needs to be selected at the time of on-boarding. The Bank will include any of its banking services including and not limited to utilize its empanelled agencies and vendors for providing the services as may be deemed fit and decided by Bank for processing GeM transactions. The transaction specific Virtual Accounts and DDO/Department Virtual Accounts will be created by Bank under the services called Electronic Cash Management Services (eCMS).

Option 1 - Challan based funding

 Once the challan based funding option is selected by NPAE, Bank will provide the integrated platform with GeM for generating challan. The details printed on challan will include the information provided

by GeM to Bank and any additional information shall be asked by Bank from NPAE Buyer as may be required for refunds.

- Bank will provide transaction specific virtual account printed on challan which will be used by NPAE Buyer to fund the GPA through RTGS/ NEFT/ intra bank fund transfer mode only. Any other mode of payment will not be allowed to NPAE for funding the GeM Pool Account
- The funds received in transaction specific virtual account will be unique for each transaction and it will be NPAE Buyer responsibility to remit the funds to correct account as provided on challan.
- Bank will validate the first six characters of virtual account and credit the amount into GPA. If first six characters are not matched, the transaction will be upfront rejected by Bank.
- 5. If the complete virtual account is not matched with the account provided on challan, bank will reject the transaction and initiate the refund to remitter account on next working day by debiting the GPA. NPAE hereby authorize the Bank to debit the GPA for initiating such refunds. The refund transaction initiated on next working day shall be settled as per cutoff timing defined by National Payment Corporation of India (NPCI) and including the bank's internal processing time. The mode of initiating such refunds will be National Automated Clearing House (NACH) Credit or any other mode as may be suitable for settlement of funds to comply with the requirements of GeM.
- 6. It will be NPAE Buyer responsibility to credit exact amount in GPA as provided in challan according to the budget provided by GeM portal. In case of any shortage, Buyer shall fund the GPA with the difference amount. If the funds received in GPA for a particular transaction are in excess above the final amount to be paid to supplier, the excess funds will be refunded to NAPE Buyer account as submitted on challan generation page.
- 7. The funds credited into GPA will be parked into DDO/ Department Virtual Account Number (VAN) created by Bank as per process defined by GeM. The DDO/ Department VAN will be in the combination of Prefix allotted by the Bank and suffix as DDO / Department Code submitted by the NPAE Buyer at the time of DDO/ Department registration. The Bank will consider the DDO / Department Code as received from GeM through integrated platform.

Option 2 - Non Challan based funding

If NPAE selects the option of non challan based funding process, buyer will fund the GPA with budgeted amount provided on GeM platform or as the case may be

The NPAE Buyer will have the options to credit the funds into DDO/ Department Virtual Account, which will be created by the Bank on request received from GeM through integrated platform and shared with GeM, by way of NEFT/RTGS/intra bank funds transfer only. Alternatively, the NPAE Buyer will fund the GPA directly and provide the list of DDO/ Departments with the details of amount to be allocated to respective Buyers. It will be the NPAE Buyer responsibility to select appropriate option and use block service provided by GeM for blocking the funds to respective DDO/ Departments. - 2. For eCMS funds will be credited into GeM Pool Account as per arrangement mentioned in the request letter for creation of virtual accounts and sweep instructions. In case, the day of credit/fund transfer as mentioned under "Arrangement" overleaf happens to be a RTGS/NEFT holiday then the credit will happen on the next working day.
- 3. If the NPAE notices an error in the information provided to HDFC Bank in any communication, it shall immediately notify to HDFC Bank and HDFC Bank will rectify the error wherever possible on a "reasonable effort Basis". In the event of NPAE receiving incorrect credit at any time whatsoever, the NPAE shall be liable and continue to remain liable to HDFC Bank for any unfair or unjust gain obtained as a result of the same.
- 4. It is also agreed that the aforesaid service will be provided in respect eCMS pertaining to advance funding in GeM Pool Account and shall not cover or be extended to any other payments or receipts of any other nature whatsoever.
- 5. The process flow is exclusive of intervening bank holidays, Sunday & other bank holidays.

Order Placement on GeM

Once the estimated cost of procurement is transferred to GeM Pool Account, GeM will verify online, the availability of fund from the bank. Once confirmed, GeM would allow the NPAE buyer to place the order/creation and floating of the e-bid/ reverse auction as the case may be, through the GeM Platform. Once order is placed on the successful bidder, to be decided through the system, the consignment delivery would be initiated by the supplier as per the schedule of contract.

2. Payment to Supplier

The payment process is triggered post the successful supply, acceptance and online issuance of CRAC by the consignee. Once the CRAC is issued online on the GeM platform, a system generated bill is created on the basis of CRAC which will be processed by the NPAE buyer/DDO/Treasury Officer online for the payment through GeM Pool Account. Online instruction for payment is routed through GeM portal to GPA managing bank for debiting the requisite fund against the contract for transfer to beneficiary account i.e. supplier's account. Against one contract, multiple payment cycle may be initiated as per the delivery of consignment, acceptance and CRAC within the Terms and Conditions defined by GeM

- 3. Maximum up to three accounts or as may be defined by GeM from time to time, would be utilized for all transactions on GeM by all the buyers of that NPAE as per Standard Operating Procedures of GeM The NPAE will map one account each to Buyers at the time of Buyer registration on GeM portal.
- 4. Bank will process the payments to Suppliers through National Automated Clearing House (NACH) Credit on NPCI platform for which NPAE will provide the application for registration with NPCI in desired format. Bank shall select the appropriate mode of payment as may be suitable within the Standard Operating Procedures of GeM

The Bank upon getting the payment instructions from GeM will initiate the payment transactions to supplier accounts through suitable mode of payment within cutoff time defined by National Payments Council of India (NPCI) including the internal processing time of Bank.

The Bank is authorized to debit the GeM Pool Account for equivalent amount for which instructions are received by the Bank from GeM through API for making payments to suppliers. This MoU will be treated

as one time instruction to Bank for debiting the GeM Pool Account and initiating the payment to Suppliers as per payment instructions received from GeM through API.

Affecting the credit into supplier accounts will be the responsibility of beneficiary bank. HDFC Bank will share the transaction status with GeM through integrated platform as per the timing of settlement and reporting defined by NPCI and status received from beneficiary bank through NPCI.

Any transactions rejected by beneficiary bank of supplier shall be credited to GeM Pool Account and status will be shared by the Bank with GeM for further action by GeM as may be deemed fit.

- Any fund in the GPA should be non-lapsable and can be used by NPAE within Standard Operating Procedures of GeM as deemed fit unless tagged to any live transaction.
- 6. In case of a SLA breach on the part of the NAPE in terms of payments to the supplier, GeM will intimate the buyer and bank on the same. Post such intimation, and non-action on the part of the NAPE with respect to payment transfer, bank will release 80% of the amount (or as notified in the terms and conditions of procurement on GeM) to the supplier mapped in the transaction basis GeM instructions received by Bank. Such a provision is required to be incorporated in GPA and should be considered as a standing instruction from the NAPE to the bank. The Bank will not be liable in case of any delays in payment to supplier under any circumstances. The residual amount cannot be withdrawn / transferred by the NAPE, in such cases till such transactions are completed. Post remaining processing, all such remaining due payments will be made to the supplier for such transactions basis instructions received from GeM.
- 7. If any balance is left after the final payment to supplier in a particular transaction, the excess funds in GPA will be refunded to NAPE Buyer account as submitted on challan generation page for refund as per timelines defined by NPCI and bank's internal processing time.
- Any instructions received after cutoff time shall be processed by bank on next working day.

- Balance confirmation in DDO Accounts for respective departments while floating their requirements on Government e-Marketplace (GeM). GeM will allow the respective departments to float their requirements only after DDO Accounts are funded from SGPA with equivalent amount.
- Marking hold on funds received from respective department on instructions received from GeM portal.
- Marking Release of funds after procurement is complete to remit the funds to supplier on instructions from Buyer through GeM.
- 10. On authorization of a payment on GeM, the bank should transfer the prescribed amount to the supplier mapped in the transaction.
- 11. Initiating the payment to suppliers same day basis API instructions are received by Bank through GeM portal within cutoff time. In case the instructions are received after cutoff time, transaction will be rescheduled for next working day. 


