<u>AGREEMENT FOR ONLINE ADMISSION REGISTRATION – 2015-16</u>

THIS AGREEMENT is made this 31st day of March in the year 2015 between the Gushkara Mahavidyalaya, P.O. Gushkara, Dist. Burdwan - 713128, W. B. of the one part AND the MSS, a Software Organization registered under the Indian Companies Act, 1956 and having its registered office at 31, G. T. Road, Dhaldighi, Burdwan, of the other part.

WHEREAS the Gushkara Mahavidyalaya is in need of the service of a proficient and trustworthy software organization for the purpose of its online admission of 1st year students in different courses and subjects for the academic session 2015-16 and other accessory works and for the said purpose invited quotations from software companies possessing the required qualities and the said software organizations by its quotation, Memo No. 172/C/M-15 dated 14.03.2015, offered his services for the required provision.

NOW, THEREFORE, THIS AGREEMENT WITNESS that the parties hereto mutually agreed as follows:

- That the MSS shall provide the software design that must be in accordance with the criteria set 1. and admission programme schedule by the Gushkara Mahavidyalaya for online admission and other relevant purposes.
- 2. That the MSS shall in consideration of its services be paid a total amount of Rs. 38,500/-(Rupees Thirty eight thousand five hundred only) during the continuance of this agreement from Gushkara Mahavidyalaya and 1st instalment of which i.e. 50% of total charges will be paid after one month of the actual operation of the system and remaining part will be paid after completion of the programme and handover of data etc. Payment always will be made through A/c payee
- There shall be two time periods regarding the online admission process software: 3.
 - (a) Software development period.
 - (i) No payment shall be made for this period.
 - (b) Software operational period.
 - (i) Normal duration for the operational period: from the date of publication of H.S. result -2015 of WBCHSE to 105th date.
 - (ii) If the situation deserves any change of the duration of the operational period, such will be done by mutual understanding of both the parties.
- That the test run for the complete online admission software process shall be completed by 8th 4.
- That the MSS shall maintain Helpdesk service support for 24x7 hours (including Telephone 5. support) at their registered office or otherwise.
- That the MSS agrees to provide option for fresh registration within this time frame without any 6. extra payment, if the situation demands that.
- That the MSS agrees that they will strictly maintain the secrecy of the merit lists. In this regard permission from due authority (college) is to be taken before floating the merit lists in the college website.

- 8. That both the parties agree that no payment shall be made at the developing stage of the software required for the purpose.
- 9. That the MSS agrees that all the facilities mentioned in the quotation (172/C/M-15) dt. 172/C/M-15 submitted to the Gushkara Mahavidyalaya must be provided by the outsourcing agency without any charge.
- 10. That the data generated by MSS as part of the process of online admission registration and other relevant functions to be handed over offline in softcopy to Gushkara Mahavidyalaya within 07 (seven) days from the date of expiry of this agreement.
- 11. That the period of 105 days of the operational period [as mentioned in Sl.No. 3.(b)(i)] and the terms and conditions fixed for the supply of the service shall be considered as of the essence of the agreement and if the software organization MSS fails to adhere to this condition, the Gushkara Mahavidyalaya shall have the right to repudiate the agreement and claim from the software organization MSS the expenses and loss incurred for the negligent activities from the part of MSS.

IN WITNESS whereof the above-named parties have respectively set their hands Dr. Swapan Kumar Pan, Principal himself acting for the Gushkara Mahavidyalaya and Sri Santi Pada Koley, the Proprietor acting for the MSS software organization and sealing the agreement with the seal at 31st day of March, 2015.
